Jo concentrates her practice on improving frontline delivery of services by supporting and challenging practitioners and their organisations to focus on delivering better outcomes for children.

Originally from Australia, between 1989 and 1999 Jo worked first on the Gold Coast in Disability Services, and then in Canberra in NGOs and the Department of Family Services. This included five years as a court advocate prosecuting cases for the Canberra Director of Children's Services. She moved to the UK in 2001, where she joined Cumbria County Council Children's Services. In addition to providing front-line support to clients, Jo was responsible for developing training programmes for social work staff. She was appointed to implement the Integrated Children's System (ICS) in Cumbria. Jo has since built upon that experience to support other authorities in successfully implement and utilise the ICS system as part of a practice-based programme.

Jo entered private practice in 2007, providing expertise to Children and Families services across the UK. Offering the benefit of her 20+ years' experience and determination to improve practice, the majority of Jo's work involves the delivery of continuous professional development programmes for social workers in group settings. She promotes the use of evidence-based practice, including the framework for assessment, data management toolset, and recording framework to improve social work interventions and outcomes and to accurately reflect the work of the practitioner.

In the capacity of expert advisor to the UK Department for Children, Schools and Families (DCSF, 2009-10), Jo supported the Government's review of the Integrated Children's System (ICS) implementation and its impact on social workers and the children and families they serve. In this role, Jo wrote national policy and practice guidance for use by all Local Authorities across the UK.

Most recently, Jo has led a team within Strengthening Practice Ltd to build a national coaching service to support social workers across the UK, in partnership with BASW(British Association of Social Work). This was developed as a response to the stress experienced by social workers during COVID and has gone on to become a permanent offering of the British Association of Social Work.

Jo also co-developed a podcast <u>Helpful Social Work</u> with her colleague Gerry Nosowska.
